- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review area contains 5 wetlands: Wetland 3 (0.13 acre), Wetland 4 (0.04 acre), Wetland 6 (0.20 acre), Wetland 9 (0.05 acre) and Wetland 10 (0.02 acre) are identified as disturbed or farmed wet meadows located in topographic depressions with no hydrologic connection to another water of the U.S. These 5 wetlands are not adjacent (bordering, contiguous, or neighboring) to another water of the U.S. and they are not separated from another water of the U.S. by man-made dikes or barriers, natural river berms, or beach dunes. The review areas range from 65-165 feet from the nearest tributary in an active agricultural area precluding any ecological interconnection with another jurisdictional water. There is no link to interstate or foreign commerce and the wetlands are not used by interstate or foreign travelers for recreation or other purposes. The wetlands do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and are not used for industrial purposes. Therefore, the Corps has determined that the subject wetlands are isolated and not regulated by the Corps under Section 404 of the Clean Water Act.**
