Explain: The review area contains two resources (labeled as Wetland 1-E(D) and Wetland 2-E(D) on Figure) that are isolated depressions with no surface or shallow subsurface connection to any waters of the United States, including an unnamed tributary of Duck Creek located approximately 0.48 mile to the south. Wetland 1-E(D) extends outside of the review area however all possible connections were reviewed. These wetlands do not border, neighbor, nor are they contiguous with another water of the U.S. They are not separated from other waters of the United States (WOUS) by man-made dikes, barriers, or berms. The surrounding land use consists of agricultural fields, open grassland, paved two-lane roadways, and residential development, precluding an ecological connection to a WOUS.

These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined these aquatic features are not regulated by the Corps under Section 404 of the Clean Water Act.

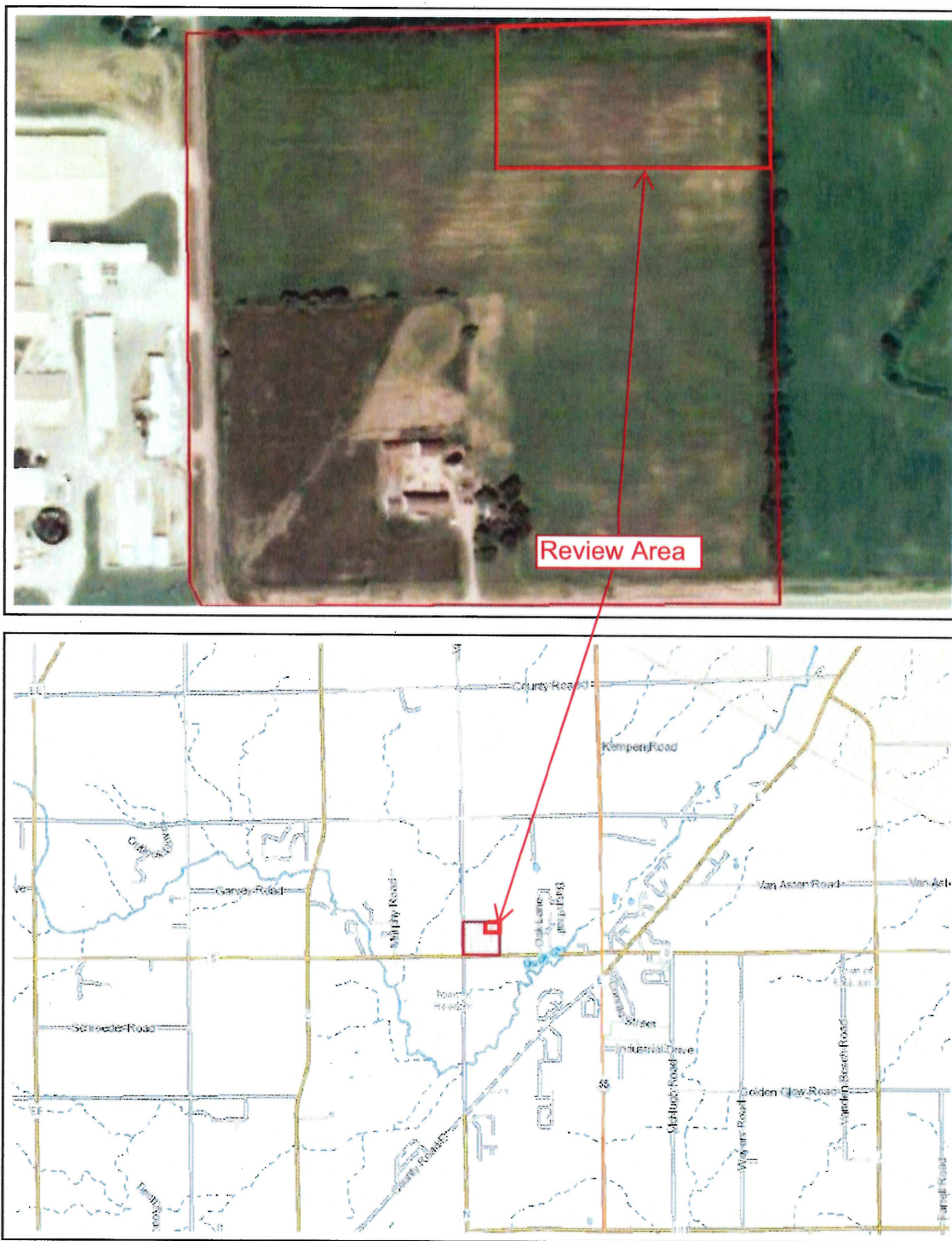

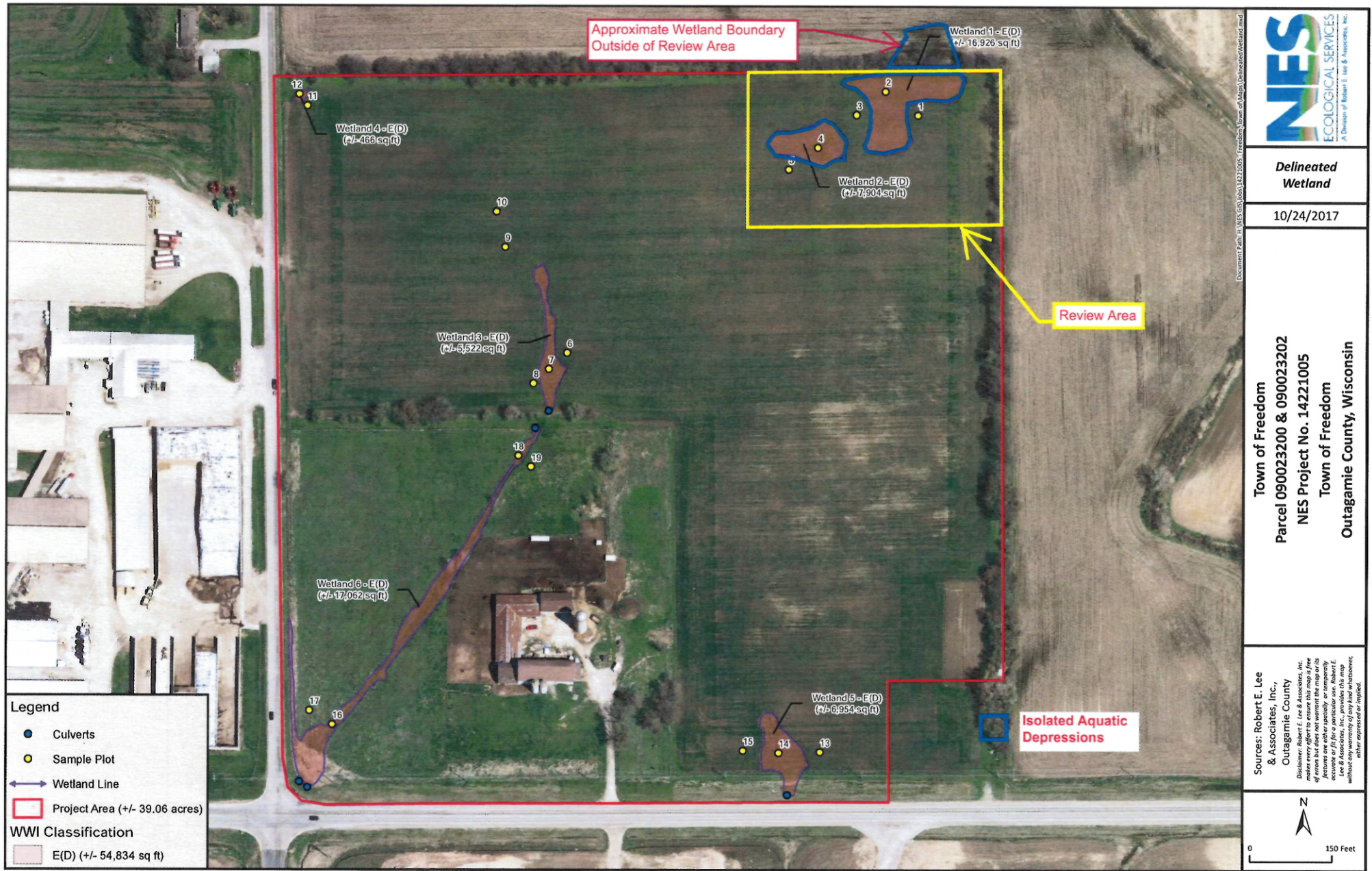
## Project Area Maps
