Explain: **The review area consists of the area labeled Wetland 3 on the attached figure MVP-2019-00309-AIS Page 2 of 5. This wetland is not bordering, contiguous with, or neighboring another WOUS nor is this aquatic resource separated from another WOUS by man-made dikes, barriers, or berms. The closest tributary is approximately 1,120 feet to the east of the wetland and the surrounding soils are predominantly non-hydric.**

The wetland located within the review area does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Furthermore, this wetland is hydrologically isolated with no surface or shallow subsurface connections to a water of the United States and does not have an ecological interconnection due to existing disturbance. Therefore, the Corps has determined that Wetland 3 is not regulated by the Corps under Section 404 of the Clean Water Act.
