Explain: **The review area contains one aquatic resource (labeled as Wetland B on Figure) that is an isolated depression with no surface or shallow subsurface connection to any waters of the U.S. including the nearest tributary which includes an unnamed tributary of Big Muskego Lake located approximately 0.30 mile to the southwest of Wetland B. This wetland does not border, neighbor, nor is contiguous with another water of the U.S. It is not separated from other waters of the United States (WOUS) by man-made dikes, barriers, or berms. The surrounding land use consists of agricultural fields, undeveloped areas, and residential development, precluding an ecological connection to a WOUS.**

**This aquatic resource does not support a link to interstate foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined this aquatic feature is not regulated by the Corps under Section 404 of the Clean Water Act.**
