- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Wetlands 1-8, located in the review area are isolated features and are not considered Waters of the US. Review of aerial photography (Google Earth 1992-2015) indicates the wetlands are depressional features. The agricultural field in which they are located does show saturated soils and drainage patterns, but a surface or subsurface connection to another water is not present. LiDAR imagery shows the wetlands as closed depressions. The nearest tributary is approximately 3,000 feet from the wetland features. These wetlands do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (agriculture) and proximity to other waters, there is no ecological connection to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetlands 1-8 are not regulated by the Corps under Section 404 of the Clean Water Act.**
