- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Wetland on project site (0.23 acres) is located in a closed depression surrounded by northern mesic forest at the termination of Clear Lake Road. The site has never been developed. This wetland is approximately 50' north of Clear Lake, and there is an approximately 10' drop in elevation down to the water level of Clear Lake over that distance. The wetland does not have any unbroken surface or shallow subsurface connections to this waterbody; it is not mapped within the 100-year flood plain. This wetland is not adjacent (bordering, contiguous, or neighboring) to another WOUS and is not separated from other WOUS by man-made dikes or barriers, natural river berms, or beach dunes. Due to the change in elevation between this wetland and the nearest waterbody, there is no science-based inference (ex. does not support life cycles of amphibians or anadromous and catadromous fish) that supports an ecological connection. Additionally, there is no link to interstate or foreign commerce and it is not used by interstate or foreign travelers for recreation or other purposes. This wetland does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that the wetland is hydrologically isolated and is not regulated by the Corps under Section 404 of the Clean Water Act.**
