A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **This JD is for two aquatic features identified as Wetland 1 (W-1) 0.86 acre and Wetland 2 (W-2) 9.96 acres in size which are located within a depression. The isolated wetlands are approximately 1.691 miles from the nearest jurisdictional water of the United States. There is no natural or man-made discrete and/or confined surface water connection between the wetlands and any jurisdictional waters, nor is there a shallow subsurface connection to any other jurisdictional water. The wetlands do not border, neighbor, nor are they contiguous with another water of the U.S., nor are they separated from other waters of the U.S. by man-made dikes, barriers, or berms. These wetlands are surrounded by land that is in agricultural crop production and commercial development, precluding an ecological connection to jurisdictional waters. The wetlands are not located in the mapped 100 year floodplain of a jurisdictional water. Therefore, during times of heavy precipitation there is a very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the wetlands. Based on a review of the USGS Quadrangle Sheet, the wetlands based on their landscape position do not appear to be part of a recognizable hydrologic system. The wetlands do not cross any state boundary and do not have a use which would associate it with interstate commerce. The wetlands do not support a link to interstate or foreign commerce because they are not known to be used by interstate travelers for recreation or other purposes; they do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and they are not known to be used for industrial purposes in interstate or foreign commerce. Therefore, the Corps has determined that wetlands W-1 and W-2 are not regulated by the Corps under Section 404 of the CWA.**
