- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **A delineation report was submitted to the Corps documenting the presence of aquatic resources within the approximately 10.50-acre review area. An office review of the delineation report for the subject site was conducted on September 18, 2019 to review the potentially jurisdictional aquatic resource: Wetland 2 (0.339 acre) as requested by Brandon Robaidek (Robert E Lee and Associates, Inc.), acting on behalf of the Laserform, LLC. One other wetland (Wetland 1-0.219 acre) was also identified as part of the delineation report, however, the jurisdictional status of this wetland is included in Section II.D.4.**

A thorough desktop review was conducted to identify any culverts and/or other hydrologic connections between Wetland 2 and nearby surface waters within and adjacent to the project site and none were found. The closest surface water found was an unnamed tributary to Dutchmen Creek, an intermittent stream over 1,200 feet to the east of the review area as identified on the USGS topo map. Wetland 2 is a small depressional feature that does not have a surface or shallow subsurface connection to the unnamed tributary to Dutchmen Creek or other waters of the United States (WOUS). Based upon information gathered as a result of the desktop review and the wetland delineation report, Corps staff determined that Wetland 2 is wholly surrounded by uplands and lacks an unbroken surface or shallow sub-surface connection to a WOUS. Wetland 2 is not separated from man-made dikes or barriers, natural river berms, beach dunes, and the like from jurisdictional waters. The surrounding land use is comprised of agricultural and open areas that could potentially provide cover or habitat between the wetlands on site and other aquatic resources such as the unnamed tributary to Dutchmen Creek. Wetland 2 would not likely have an ecological connection to a WOUS due to the distance between the wetlands and the nearest tributary (unnamed tributary to Dutchmen Creek).

Wetland 2 does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; it does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes for interstate or foreign commerce. Wetland 2 is determined to be non-jurisdictional under the Clean Water Act because it lacks connections and/or relationships sufficient to serve as a basis for jurisdiction.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
