Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined not to be jurisdictional.  
Explain: **The review area contains one wetland, labeled W1 on the attached figure MVP-2019-00792-AIS Page 5 of 6. This wetland is not bordering, contiguous with, or neighboring another WOUS nor is this aquatic resource separated from another WOUS by man-made dikes, barriers, or berms. The closest tributary is approximately 2,125 feet to the northeast of the wetland. Some aerial imagery appears to show drain tile, which USGS StreamStats data indicates drains to Hooker Lake to the east, but the project agent has averred that no inlet structure was able to be found in W1. In addition, the placement of the tile outlet would result in drainage being caught by a stormwater pond constructed in uplands southeast of the project site in 2005 or 2006. A 2006 Corps delineation concurred that there were no wetlands on the project site, though the delineation was not re-reviewed after five years and any construction work onsite has long since ceased.**

**The wetland located within the review area does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Furthermore, this wetland is hydrologically isolated with no surface or shallow subsurface connections to a water of the United States and does not have an ecological interconnection due to existing disturbance. Therefore, the Corps has determined that W1 is not regulated by the Corps under Section 404 of the Clean Water Act.**
