Explain: **The review area consists only of W-2 as identified on the figure labeled MVP-2019-00871-AIS Page 2 of 6. This wetland is not bordering, contiguous with, or neighboring another WOUS nor is this aquatic resource separated from another WOUS by man-made dikes, barriers, or berms. The closest tributary is approximately 300 feet to the northwest of the wetland. W-2 sits at a topographic low point, causing it to be frequently inundated with water while the rest of the area is not.**

**The wetland located within the review area does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Furthermore, this wetland is hydrologically isolated with no surface or shallow subsurface connections to a water of the United States and does not have an ecological interconnection due to existing disturbance. Therefore, the Corps has determined that W-2 is not regulated by the Corps under Section 404 of the Clean Water Act.**
