A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The Review Area contains one wetland (W1) that is an isolated depression with no surface or shallow subsurface connection to another water of the U.S. The wetland is bounded on the west, north, and east by commercial developments and to the south by an abandoned railroad grade. The railroad grade has no ditches or culverts. The wetland boundary extends outside of the review area in the southeast corner. The wetland boundary outside of the review was evaluated in the field which confirmed it is bounded by uplands with no drainage features. The Wisconsin Wetland Inventory indicates W1 may be part of a larger wetland complex. Field review confirmed that W1 is separate and isolated from the larger complex.**

This wetland does not border, neighbor, nor is contiguous with another water of the U.S. It is not separated from other waters of the United States (WOUS) by man-made dikes, barriers, or berms. The surrounding land use is primarily commercial and recreational lands. The nearest tributary is 3,250 feet to the southeast and the landscape position of W1 and surrounding development preclude any ecological connection. This aquatic resource does not support a link to interstate foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined this aquatic feature is not regulated by the Corps under Section 404 of the Clean Water Act.
