- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review area contains 1 wetland: Wetland 1 (6.51 acres). This feature is identified as a landscape depression, described as a fresh wet meadow, with no hydrologic connection to another water of the U.S. The feature is within a topographic depression which can be seen on the 1:24K WI- Middleton topography map. This wetland had been previously determined to be isolated in March 26, 2010 and May 9, 2005 . The wetland is not adjacent (bordering, contiguous, or neighboring) to another water of the U.S. and is not separated from another water of the U.S. by man-made dikes or barriers, natural river berms, or beach dunes. The review area is an agricultural field adjacent to a residential area and the wetland within the review area is 2,439 linear feet from the nearest tributary, precluding any ecological interconnection with another jurisdictional water. There is no link to interstate or foreign commerce and the wetland is not used by interstate or foreign travelers for recreation or other purposes. The wetland does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and is not used for industrial purposes. Therefore, the Corps has determined that the subject wetland is isolated and not regulated by the Corps under Section 404 of the Clean Water Act.**
