- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Wetlands 1 and 2, located in the review area, are isolated wetlands and are not considered Waters of the US. The wetlands were identified in a wetland delineation completed by Evergreen Consultants LLC. Review of aerial photography (Google Earth 2008-2015) indicates the wetlands are depressional features in an agricultural field that do not have a surface or subsurface connection to any other water. Topographic maps do not indicate drainage to another water. No indications of drainage features between the agricultural fields were identified. These wetlands do not border, are not neighboring to or contiguous with another water of the U.S. and are not separated from another water of the U.S. by man-made barriers, dikes or berms. Aerial photos also indicate that the vegetation within the wetlands has been consistently altered by farming activities. The wetlands offer little to no habitat function and are separated from other aquatic features. There is no ecological connection to other wetlands or waters. These aquatic resources does not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetlands 1 and 2 are not regulated by the Corps under Section 404 of the Clean Water Act.**
