SECTION II: SUMMARY OF FINDINGS

There are **no** "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

Explain: **The review area consists only of the wetlands labeled Wetland B and Wetland C on the attached figure MVP-2019-00724-AIS Page 2 of 5. These wetlands are not bordering, contiguous with, or neighboring another WOUS nor are these aquatic resources separated from another WOUS by man-made dikes, barriers, or berms. They have no surface connections to any other WOUS. The closest tributary is approximately 335 feet to the north of the nearest wetland (Wetland C). There is a ditch near Wetland B, but a review of ground level photography reveals it ends approximately 450 feet before reaching any other water with no culvert to connect it to potential WOUS. The soils in the area are non-hydric.**

The wetlands located within the review area do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Furthermore, these wetlands are hydrologically isolated with no surface or shallow subsurface connections to a water of the United States and do not have an ecological interconnection due to existing disturbance. Therefore, the Corps has determined that Wetland B and Wetland C are not regulated by the Corps under Section 404 of the Clean Water Act.
