Explain: **The review area contains one wetland, outlined in red and labeled W-1 on the attached figures MVP-2019-00891-AIS Page 1-5 of 5. This determination applies to the full wetland as outlined in red. In its current state, this wetland is not bordering, contiguous with, or neighboring another WOUS nor is this aquatic resource separated from another WOUS by man-made dikes, barriers, or berms. The closest tributary is approximately 3,870 feet to the north of the wetland. While the wetland borders a road, a review of street level imagery confirms that there are no culverts or ditches that connect it to any other aquatic resources.**

The wetland located within the review area does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Furthermore, this wetland is hydrologically isolated with no surface or shallow subsurface connections to a water of the United States and does not have an ecological interconnection due to existing disturbance. Therefore, the Corps has determined that W1 is not regulated by the Corps under Section 404 of the Clean Water Act.
