- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Wetlands located in the review area (Labeled: W-1, W-2) are isolated features and are not considered Waters of the US. The wetlands were identified in a wetland delineation completed by Heartland Ecological Group, Inc. Review of aerial photography (Google Earth 2000-2018) indicates the wetlands are depressional features that do not have a surface or subsurface connection to any other water. Wetland W-1 is located within an abandoned gravel pit. W-2 is located within an active agricultural field. 1-foot topographic contour maps show that elevations are higher surrounding the identified wetlands. There is a large berm to the south of the wetlands that would prevent water from extending to roadside ditches, if present. These wetlands do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (agriculture, residential and commercial development) and proximity to other waters, there is no ecological connection to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that W-1 and W-2 are not regulated by the Corps under Section 404 of the Clean Water Act.**
