These wetlands were created in conjunction with on-site grading and are not waters of the US. This was confirmed by reviewing historic aerial imagery. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following activities to be waters of the United States; water filled depressions created in dry land incidental to construction activity.**
